2. Announcement of Victim Support Grant - Chief Spowart

Director Brisson first confirmed the presenter's statement that a 5-acre lot was necessary for the new build and asked if there were ways to reduce the footprint if necessary. Mr. Taylor's response was yes however it would come at an increased building cost. Mayor Towndale thanked Mr. Taylor for the presentation and agreed with Director Brisson that finding space would be a challenge however the sooner we move forward the better as workplace environment is important. The CPS Board also approved moving forward with step #2 of the process.
